- I. Roll Call: Present: Terri Miller, Gina Panella, Tracy Stowe, Carolyn Chen, Courtney Hunt, Lori Kuhlman, Robin Metz, Dean Miller. Excused: Christine Cox, Janette Marnik
- II. The minutes from the January meeting were approved and the agenda for the current meeting was adopted, both by a unanimous vote.
- III. President's report
  - A. Mr. Ishman was not able to attend today's meeting as planned.
  - B. Easter candy fundraiser may be hindered because some of the local schools are also selling Rosalind's candy for easter.
  - C. The Learn to Compete exhibition went very well and we are considering doing it again next year.
- IV. Treasurer's report: We have \$18,888.56 in the checking account. We have to pay January's ice bill, the coaches' salaries for LTS, and BCIA's share of LTS proceeds.
- V. Test chair report: Christine is trying to set up a test session for April 1, 2016, if this day works out for the BCIA. So far, judges Betty Gallagher and Kerri Bacassa are able to come. She is waiting to hear from Donna Cerami. We will need volunteers for judges' hospitality, skater hospitality, and check-in, as well as runners and an ice monitor.

- VIII. Unfinished business
  - A. Governing council: two people are able to go, so Terri nominated Christine Miller as the second person. This was seconded and unanimously approved.

    2. Dress rehearsal will be April 21, during the usual LTS and BCFSC freestyle times (4:30-6:30).
    3. There is a lot of practice time available; coaches can pick what works for them.
    4. Vendors: Megan will be there for pictures. We are open to suggestions for other vendors.
    5. Guest skaters: We will again ask Kaitlyn Nemastil. We would also like to ask someone from the Mount Lebanon Skating Club, such as Sharon Brooks' daughter. They are a small club as well and we might mutually benefit from having a good relationship.

6. The Steel City Blades would like to have all 5 of their teams perform at the show.
7. Tickets: A motion was made by Terri for each skating family to have one free ticket for the show. This would include guest skaters, the synchro team members, LTS families, and all club members. This was seconded and approved.
8. Qualifications: All skaters MUST have a current USFS number, either through their respective clubs or through LTS.

10. Guidelines: We will use last year's guidelines, with a few minor changes..
