**FUNDRAISING/VOLUNTEER POLICY & AGREEMENT**

In order for the BCFSC to be able to provide services to its members (test sessions, competitions, ice shows, skating sessions, banquets etc.), we must rely heavily upon the willingness of the membership to help provide the man/woman power necessary to help complete the various tasks involved. Anyone in the club able to help is welcome and their efforts are needed. Without a larger base of volunteers willing to help, we may not be able to continue providing the same level of services we have in the past. A \$25 refundable volunteer deposit will be collected or rolled over each season.

All BCFSC members, with the exceptions of College and Professional Members, are required to participate in ALL fundraising activities. A “buy out” option of each fundraising activity will be available and made known at the start of each fundraiser. A family having more than one member of the club may fundraise as a family unit. Non-participation or failure to “buy out” will result in being deemed as a member “Not in Good Standing” and therefore will be ineligible to test or compete. In addition to fundraising, ALL members excluding College and Professional Members will be required to volunteer at least six (6) hours-per member or family unit- at a BCFSC event. Beaver County Figure Skating Club events include but are not limited to; test sessions, serving on a committee, BCFSC Competition, Spring Ice Show, ice monitoring, fundraising events. Members not in compliance with the amount of volunteer time will be considered Members “Not in Good Standing” and will be ineligible to test or compete.

**BEAVER COUNTY FIGURE SKATING CLUB**

I hereby release, discharge, and covenant not to sue the *Beaver County Figure Skating Club*, United States Figure Skating, it’s directors, officers, administrators, sponsors, volunteers, agents, employees, staff, instructors, trainers, other participants and if applicable, owners and lessors of premises on which the “activity” takes place (each considered one of the “Releasees” herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the “releasees” or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

The *Beaver County Figure Skating Club* has the right, but not the obligation, to provide rules, regulations and/or ice monitors for Club Ice. We hereby acknowledge that the *Beaver County Figure Skating Club* shall not be responsible for the supervision of the members at Club Ice.
